- Out of the total 86,31,311 partly paid-up shares shown above, the Company has received first and final call money on 4,37,248 shares and obtained listing permission for the same from Stock Exchanges however these shares could not be credited to the demat account of respective allottees under fully paid ISIN due to technical rejections, and accordingly as on September 30, 2024, these 4,37,248 shares continue to be reflected under the partly paid ISIN in the records of the Depositories. Further, on May 24, 2024, the Board of Directors of the Company have approved forfeiture of balance 81,94,063 unpaid partly paid-up shares; however the corporate action for forfeiture is in process and hence as on September 30, 2024, these 81,94,063 shares are reflected under partly paid ISIN.
- As on September 30, 2024, the paid-up capital of the Company comprises of 1364,52,30,821 fully paid-up equity shares (including 4,37,248 shares as fully paid up since call money has been paid on these shares and excluding 81,94,063 unpaid partly paid shares which have been forfeited on May 24, 2024).
- The voting rights are considered in proportion to the amount paid-up on the face value of the shares, i.e. Fully paid-up shares x Rs.2. Accordingly in column IX of Table I, II and III, fully paid-up shares are considered as having one voting right whereas partly paid-up shares are considered as having Nil voting right since these are forfeited.
